**ORDER**

Sri G.M. Menon, Prabhat Castle, 10-3-32/13, East Marredpally, Secunderabad has filed 2<sup>nd</sup> appeal dated: **19-1-2009** which was received by this Commission on **19-1-2009** for not getting the information sought by him from the PIO and Appellate Authority / Director (RR&Comml), O/o the APCPDCL, 3<sup>rd</sup> Floor, Singareni Bhavan, Red Hills, Hyd.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: **30-10-2008** before the PIO, O/o the APCPDCL, 3<sup>rd</sup> Floor, Singareni Bhavan, Red Hills, Hyderabad seeking the following details:-

*“To furnish the certified copy of the Sale Deed dated: 2-1-1974 executed between A.P. Housing Board and P. Ramankutty Menon for premises No. 10-3-32/13, East Marredpally, Secunderabad which would have been submitted to the APCPDCL authorities while seeking sanction of 15 Nos. 3 ph domestic services and which would have been submitted to the Intuition of A.P. Lokayukta along with the receipt dated: 5-11-2007 of the Chairman & Managing Director, APCPDCL, Hyderabad and report dated: 3-11-2007 of the Jt. Managing Director (V&S), A.P. TRANSCO, Hyderabad in complaint Case No. 730/2007/B1 and No. 761/2007/B1”.*

The APIO / Divisional Engineer (Tech), Operation Hyderabad (North) Circle, Mint Compound, Hyderabad-63 through letter No.SE/OP/North/Hyd/Tech/D.No.1593/09, dt.18-11-08 informed the Appellant that the copy of Sale Deed dated: 2-1-1974 executed between the A.P. Housing Board and P. Ramankutty Menon of premises No. 10-3-32/13, East Marredpally, Secunderabad which might have been submitted to APCPDCL authorities is not available with section office or sub-division office.

As the Appellant did not satisfy with the reply received from the APIO, filed an appeal u/s 19(1) dated: **25-11-2008** before the Appellate Authority / Director (RR&Comml), O/o the APCPDCL, 3<sup>rd</sup> Floor, Singareni Bhavan, Red Hills, Hyderabad seeking action against the PIO and to furnish the information.

The appellant stated that as he did not get the information even after 30 days of filing 1<sup>st</sup> appeal, preferred 2<sup>nd</sup> appeal before the Commission requesting to take action against the PIO and the Appellate Authority for not furnishing the information sought by him and also to arrange to furnish the information.

After examining the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 13.08.2009.

On 13.08.2009 the case was called. The Appellant was absent due to demise. The Respondent was present and through his letter No. CPDCL/AA/SPIO/RTI-2005/D.No.218/09, dated 12.8.2009 informed that the Appellant Sri G.M. Menon, Prabhat Castle, 10-3-32/13, East Marredpally, Secunderabad has expired on 03.07.2009 at 7.00 A.M. due to Cardio Respiratory Failure as certified by Geeta Multi Speciality Hospital, 10-1-5/C, Road No.4, West Marredpally, Secunderabad. The Respondent has filed copy of the Death Certificate issued by Geeta Multi Speciality Hospital. (Copy retained).

It is noticed that the notice in Case No.454/CIC/2009 dated 01.08.2009, despatched under Certificate of Posting to the Appellant has not been returned to the Commission and no legal heir of the Appellant was present for the hearing.

As per regulation No 21 of APIC Management Regulations 2007, the proceedings pending before the Commission shall abate on the death of the appellant or complainant.

In the aforementioned circumstances, the appeal stands *abated*.
